Job purpose:

To project manage, coordinate and administer core elements of the Youth programme, in the Participation Department across both our venues.

Main duties and responsibilities:

Plan and deliver programs of work in response to Participation objectives and under direction from the Creative Learning Manager

- Manage a Youth Programme budget in conjunction with the Creative Learning Manager
- 2. Programme and project manage the Youth offer ensuring the activities and regular groups are accessible, diverse and groups are at capacity.
- 3. To devise and co-plan the curriculum the Youth offer ensuring provision is delivered to a high quality and meeting department objectives.
- 4. To facilitate sessions where required.
- 5. To project coordinate our youth company in our annual Summer Youth Project and deputise for our Christmas Youth Production.
- 6. To support recruiting freelance practitioners in running youth provision, setting out expectations and supporting where necessary.
- 7. To line manage the Youth Coordinator.
- 8. Liaise with the Youth Company Programme Leader ensuring youth outreach provision has clear pathways into the venues.

- 9. Liaise with the Storage and Production Supervisor to deliver industry leading production arts training, work experience, shadowing and placement opportunities.
- 10. Liaise with the Dance Programme Leader in ensuring dance provision is embedded into our Youth offer.
- 11. Support participants, including delivering effective behaviour management strategies.
- 12. Liaise with resident, associate & visiting companies and colleagues as well as public and community bookers offering a comprehensive programme of activities for the youth programme.

General

- Lead backstage tours and support on wider participation activity where reasonably required.
- Lead on monitoring and evaluation of all youth activities across two venues.
- Liaise with marketing to promote the work of the Participation Department including a social media presence and website content.
- Ensure legal paperwork is in place (licenses, H&S risk assessments etc.)
- Be responsible for ensuring the safety and security of the Youth offer including workshops and tour participants. Employing First Aid, undertaking Risk Assessments and following Safeguarding procedures as appropriate
- Liaise with other departments on youth activity, ensuring all events are communicated in a timely and effective manner.
- Support the Creative learning Manager to ensure the smooth running of events and general office-based activities.
- Represent the Participation department and the venues at internal, external, regional and national events.
- Maintain and uphold safeguarding policy and protocol and manage sensitive data in line with GDPR guidelines.
- Undertake training in First Aid and act as a First Aider at all participation activity.
- Carry out any ad hoc tasks, projects and additional activities as may be required
